- 8. News from Churches

Victoria Park – Ros Murray reported the Café and its outreach was going from strength to strength. Links have been made with the Talbot School with them engaging in Godly Play. Another group of children came to make and serve teas & coffee.

Broadstone – Joan Jackson reported about the 20 years celebrations of the rebuild, with many events taking place during the year starting with a craft fair on Saturday 11th March. The church is actively working to encourage a greener environment. Thirsty Thursday and Messy Church continue to thrive.

Poole – Eifron Hopper reported the Circuit Youth Group was continuing to be very successful and would encourage young people across the circuit to join them. They are blessed with many children attending their services. The Spire has been working with the council on the Food & Warmth incentive providing free teas and coffee and 'kids eat free'; also links with the foodbank to give a free meal to someone in need. The Spire have a Sharing Sunday once a month. Deacon Gill Judge reported they have a good relationship with the Old Town School and are expecting 60 children at the Easter Messy Church.

Upton – Chris Snape reported the Daisy Chain sessions continue to be popular, the last session having 30 children and 18 adults attending. The Pre-School is full. The decking at Upton is being replaced and extended.

Wool – Rev Karen James reported the ecumenical links with the Anglican and Catholics were strong in Wool with the Padre at Bovington Camp keen to link in. At Easter they will be sharing in a Walk of Witness.

Swanage – Rev Karen James reported Messy Church will be held in April. The First Steps Toddler Group has more children attending now.

9.1 Mission Updates – Deacons Gill reported she and Deacon Suzie Viana are thinking of embarking on a new 'Beach Mission'. From a beach hut they want to offer teas and coffees, Sunday services and anything else to reach out into the community. They both continue with the Godly Play once a fortnight at Victoria Park.

12. Property

12.1 Update regarding sale of Wareham Church

The sale of Wareham Church is still awaiting the Local Authority's decision on their Nutrient's Policy which could be in April if the last communication still stands. The buyer is still on board according to the Agents.

12.2 Update on Manses:

York Road

The manse was valued at £525,000. The sale needs to be registered with TMCP and a QRS valuation is required which Karen Price is working on.

Wimborne Road

The sale of Wimborne Road Manse is proceeding following our acceptance of an offer of £450,000.

St Luke's Road

New tenants now occupy the manse.

Browning Avenue

Tony reported there was a problem with the pipework for the central heating and a number of radiators needing to be replaced, the property only heats to 16 degrees; cost of the repairs £2500. There is also an ongoing problem with damp and estimated cost to correct £50000. It is proposed that the bare minimum of work be done to the manse to make it comfortable, with a view to selling when Tony leaves.
