# 9a. Staffing

### **Rev Gareth Higgs / Cherry Hill Grove Manse**

The Rev Gareth Higgs, currently a superintendent minister living in Plymouth, is taking up a new appointment at Moorlands College. As the Cherry Hill manse is currently unoccupied it is suggested Gareth and his family move into the manse at a rent of £900 per calendar month. This rent is below the commercial amount the property could potentially obtain but Gareth has offered to:

Take 2 -3 appointments on the quarterly plan Serve on the new Spire Management Committee Cover pastoral emergencies when no other minister available

As this is a new situation, we have to apply to Connexion for permission

In preparation the meeting agreed unanimously to the recommendation to rent the property at £900 PCM. The meeting also agreed the application to an application being made under Model Trust 20 for this arrangement, Karen to email detail of applicant

A vote of thanks was expressed to Rev Betto Viana for his commitment to the Circuit over the last ten years as this will be his last Circuit Meeting.
